At the regular April meeting held on April 26, 2018 Mr. Campbell attend the Superintendent Executive Committee meeting on April 13, 2018 at Delaware County Board of DD. Ohio Association of County Boards (OACB) was successful with getting HB 47 signed into law to maintain tax exemption for Housing Corporations. OACB is still backing legislation to give County Board school staff 12 month credit under Public Employment Retirement System. The Ohio Department of Developmental Disabilities is working on simplified billing to reduce the time Service and Support Administrators spend on revisions to Individual Service Plans. Electronic Visit Verification will affect Homemaker Personal Care services billed in 15 minute units. A committee is working on proposed changes to Non-Medical Transportation. The judge has defined the class action to those given options counseling as of March 31, 2016 for moving out of a developmental center or an intermediate care facility and do not currently have waiver funding. A committee will work on issues with the Ohio Department of Developmental Disabilities denial of private duty nursing.

Mr. Campbell went over calamity days for the 2017-2018 school year. The School was closed for 7 days and Board was closed for 6 days. There were six 2 hour delays and 1 early dismissal. The school met the required hours of student instruction set by Ohio Department of Education even with the delays and days closed.

In other business, the Board:

- Approved payment of \$2,598.38 for March bills in the Hot Lunch account;
- approved payment of \$119,003.32 for March bills in the General Funds account;
- approved payment of \$24,684.07 for March bills in the Residential Services account;
- approved payment of \$439.04 for March bills in the DD School Levy account;
- approved the resolution to renew the 3.6 mill 10 year Carroll County Board of DD operating levy;
- approved the program division/committee reports;
- approved the Ethics Council recommendation of 2 new and 1 renewal applications for Family Selected Services;
