At the regular August meeting of the Carroll County Board of Developmental Disabilities held August 22nd, the Board heard from Superintendent Matt Campbell reported receiving the Carroll County Board of DD's 2013 determination of special education program performance conducted by the Ohio Department of Education's Office for Exceptional Children (OEC). Local education agencies (LEAs) can receive one of four determinations: *Meets Requirements*, *Needs Assistance*, *Needs Intervention* or *Needs Substantial Intervention*. The Board received a meets requirements determination for 2011 -2012 school year. Mr. Campbell attended the 2013 Partnership Symposium and Summer Superintendent Conference on 8-7 through 8-9-2013 at Mohican State Park Lodge. The Partnership Symposium focused on dealing with change and how collaboration between county boards, providers, guardians, and self-advocates will assist with doing more services with less funding. Union County and Coshocton County discussed how they privatized their workshops. August 8, 2013 of the Superintendent Conference The Impact Group presented on crisis communication, panel discussion on managed care, Department of Developmental Disabilities updates from Director John Martin, and Ohio Association of County Boards updates from new Executive Director Bridget Gargan. On August 9, 2013 Superintendents had a roundtable discussion on "Does our system work?" Mr. Campbell reported the Board will be posting again to fill a Board position that has been vacant since January 2013. Mr. Campbell also attended an Ohio Association of County Board event on August 21, 2013 in Columbus covering the Biennial budget changes and needed system changes to focus on community employment.

In other business, the Board:

- Approved the 2013 Superintendent Professional Development Plan;
- Approved the contract between the Carroll County Board of Developmental Disabilities and Carroll Hills Industries Inc. for adult services for 2013 to 2014;
- approved payment of \$428.10 for June bills in the Hot Lunch fund;
- approved payment of \$88,122.51 for June bills in the Carroll County Board of DD General Funds account;
- approved payment of \$3,445.57 for June bills in the Residential Services fund;
- approved payment of \$3,939.01 for June bills in the School Levy fund;
- approved payment of \$198.48 for July bills in the Hot Lunch fund;
- approved payment of \$44,196.37 for July bills in the General Funds account;

- approved payment of \$79,826.05 for July bills in the Residential Services fund;
- approved the Ethics Council Recommendations of 12 applications for Family Selected Services;
