At the regular August meeting of the Carroll County Board of Developmental Disabilities held August 27, 2015 the Board heard from Superintendent Matt Campbell that he attended the Superintendent Executive Committee meeting on July 10, 2015 held at Franklin County Board of Developmental Disabilities. Ohio Association of County Boards executive director Bridget Gargan discussed the biennial budget effect on county boards in regards to Tangible Personal Property tax and tax equity. Ohio Department of Developmental Disabilities (DODD) Director John Martin and Deputy Director Lori Horvath talked about the agreement between the DODD and Centers for Medicare and Medicaid Services plan of correction to meet the new conflict free case management rule. Mr. Campbell attended the 2015 Partnership Symposium on August 5 and the Summer Superintendent Conference on August 6-7 at Polaris Hilton. Topics of interest include Medicaid Manage Care, bond and levy overview, lean management, new waivers, and conflict free case management. Carroll County was awarded 2 Individual Options Waivers and 2 Self Waivers that are state funded to reduce the waiting list. Conflict free case management benchmark report is due to the Ohio Department of Developmental Disabilities by September 1, 2015. Mr. Campbell was contacted by the Federal Environmental Protection Agency (EPA) and was told that the Board application made it through the first round of consideration. He is working with Region #5 EPA to complete all necessary paperwork to receive the grant award. Mr. Campbell reported receiving a resignation of Board member Richard Jenkins. The Board thanks Richard Jenkins for his 4 years of service.

In other business, the Board:

- approved payment of \$226.31 for June bills in the Hot Lunch account;
- approved payment of \$97,288.04 for June bills in the General Fund account;
- approved payment of \$4,500.83 for June bills in the Residential Services account;
- approved payment of \$100,645.07 for June bills in the DD School Levy account;
- approved payment of \$67,750.27 for July bills in the General Fund account;
- approved payment of \$50,095.00 for July bills in the Residential Services account;
- approved the Program Division Reports;
- approved the Carroll County Board of DD and Carroll Hills Industries 2015 to 2016 adult services contract;
- approved the Carroll County Board of DD 2015 to 2016 school year bus and van routes;

- approved the resolution to revise the Personnel Policies and Procedures Manual;
- approved the 2015 Carroll Hills School Preschool adjusted tuition rate based on income for students without an Individuals Education Plan. If family makes more than 200% of the poverty level according to the chart, the family will pay \$6.25 per day, which is \$25 a week.
- approved 7 new and 20 renewal application for Family Selected Services;
