At the regular August meeting of the Carroll County Board of Developmental Disabilities held August 25, 2016 the Board and Superintendent Campbell welcomed the new Chief Executive Officer of Carroll Hills Industries, Mr. Edgar J. Barnett. Mr. Barnett has 25 years of service in the developmental disability field. He will be helping Carroll Hills Industries apply for their provider certification with the Ohio Department of Developmental Disabilities.

Mr. Campbell attended the 2016 Partnership Symposium between the Ohio Provider Resource Association and the Ohio Superintendents of County Boards of DD on August 10 in Cleveland. He also attended the Ohio Superintendent of County Board of DD 2016 Summer Conference from August 10 through 12 in Cleveland as well. Topics of interest included the integration of individuals with developmental disabilities in the community, staff shortage & turnover of providers, quality services, the SELF (Self-Empowered Life Funding) waiver, transitioning adult services from the County Board to private providers and leadership.

Mr. Campbell reported receiving an email from the Ohio Department of Education that Carroll Hills School 2016 Special Education rating is "Meets Requirements". The primary basis of this rating is the final special education program data the district submitted through EMIS for the 2014-2015 school year.

The Board received approval of the final report from the Environmental Protection Agency Clean Diesel Funding Assistance Program grant for fiscal year 2015

Business Manager Ray Heaston reviewed how the Board has dual roles as a funder and a provider of Medicaid Waiver services. The Board recently received a cost report settlement for services provided in calendar year 2011 in the amount of approximately \$150,000. An audit is in the process for both the 2012 & 2013 Cost Reports. The Board recently signed a contract with Cumberland Therapy Services, LLC to provide a speech therapist for Carroll Hills School.

In other business, the Board:

- approved payment of \$202 for July bills in the Hot Lunch account;
- approved payment of \$73,308.66 for July bills in the General Funds account;
- approved payment of \$23,830.99 for July bills in the Residential Services account;
- approved 2 program division reports;
- approved 2 renewals for Family Selected Services;

- entered into executive session at 6:06 pm to consider matter required to be kept confidential by federal law or regulations or state statutes. Executive session ended at 6:25 pm.
