At the regular February meeting of the Carroll County Board of Developmental Disabilities held February 26 the Board heard from Superintendent Matt Campbell that he attended the Superintendent Executive Committee meeting on February 13, 2015 held at Franklin County Board of DD. Ohio Department of Developmental Disabilities Director Martin was there to discuss the Governor Kasich's proposed Biennial Budget and direction of services. June 30, 2017 Youngstown Developmental Center and Montgomery Developmental Center will be shut down by the State. Starting July 1, 2016 the Ohio Department of Developmental Disabilities will no longer certify independent providers. Ohio Department of Developmental Disabilities will be funding 2,000 Individual Options Waivers and 1,000 Self Empowered Life Funding Waivers to further reduce those in Developmental Centers and Intermediate Care Facilities. The Board will have to make a decision to become compliant with conflict free case management which means no longer providing transportation, employment, or day services for those receiving Medicaid waiver funds.

Carroll Hills School has been closed for 11 calamity days. The school has also had two 2 hour delays and one hour delay. Carroll Hills students will have to make up 2 days over spring break on March 30 and 31 and 1 day on April 17, 2015. 9 month school staff will have to make up 6 days; 4 days over spring break March 30 and 31 when students will be present and April 1 and 2 as in-service days; 1 day on April 17 and 1 day added to the end of the year on June 2, 2015. Carroll Hills School will be closed for students on March 18, 2015. Carroll Hills School staff will attend a training called "Don't look now! Your Behavior is showing! What all adult brains should now about all children's brains" at Atwood Lodge on March 18, 2015.

Ohio Department of Developmental Disabilities will require in 2015 that Board members complete specific webinars on Centers for Medicaid and Medicare Services (CMS) Final Rule on Home and Community Based Service Settings.

In other business, the Board:

- approved payment of \$1,162.84 for January bills in the DD School Levy account;
- approved payment of \$2,223.21 for January bills in the Hot Lunch account;

- approved payment of \$129,892.35 for January bills in the General Fund account;
- approved payment of \$43,813.61 for January bills in the Residential Services account;
- approved the Program Division Reports;
- went into executive session at 6:10 pm to consider the compensation of a public employee and return to session at 6:22 pm;
- approved a 3% raise for all classified and contract board employees effective the next payroll;
