At the regular January meeting held on January 25, 2018 Mr. Campbell went over the 2017 Annual Action Plan Outcome summary. Carroll Hills Industries was officially privatized on January 1, 2018. This means that the Board no longer provides day services for adults who receive federal funding through Medicaid Waivers. The Board provides the required match funding for all Carroll County Providers billing Medicaid Waiver services. The Board is also responsible to provide oversight services that is completed by Service and Support Administrators (SSA). There have been delays with Carroll Hills Industries acquiring insurance, phone services, and computer software. Carroll Hills Industries also sent a proposal for payroll services for those individuals receiving Board services of community employment and day services for those who do not have Medicaid Waiver funding.

The Board hired Dave Henry as a maintenance staff at Carroll Hills School. The Board now has voice mail. The public will still reach the executive secretary for phone calls which she will be able to take a message or forward to voice mail. EM Media completed another video which may be viewed on Carroll Hills Facebook titled Noah Gray. The Board will also have commercials on WTOV 9 morning news and digital impressions through YouTube, Comcast, and Hulu to spot light Board services.

Business Manager Ray Heaston went over the end of the year financial reports. The year to date expenses for 2017 were \$5,186,496.90 and revenue was \$5,861,757.94.

In other business, the Board:

- Approved payment of \$1,640.80 for November bills in the Hot Lunch account;
- approved payment of \$19,588.14 for November bills in the DD School Levy account;
- approved payment of \$124,695.81 for November bills in the General Funds account;
- approved payment of \$4,515.01 for November bills in the Residential Services account;
- approved payment of \$1,340.23 for December bills in the Hot Lunch account;
- approved payment of \$79,340.87 for December bills in the General Funds account;
- approved payment of \$176,355.71 for December bills in the Residential Services account;
- approved payment of \$3,344.52 for December bills in the DD School Levy account;
- approved the payroll services contract between the Board and Carroll Hills Industries not to exceed \$26,000.04 per year;
- approved the Ethics Council recommendation of 3 new applications for Family Selected Services;
