At the regular January meeting held on January 24, 2019 Mr. Campbell reported the Ohio Department of Developmental Disabilities completed the accreditation and MUI review on January 10, 2019. Carroll County Board of DD received no citations from accreditation and the MUI review. The Board will receive a 3 year accreditation. Mr. Campbell wants to thank all staff for doing an outstanding job! It is great to get a 3 year accreditation, the highest accreditation that a Board can currently receive, but it is outstanding that the Board received no citations!

Mr. Campbell attended the Superintendent Executive Committee meeting held at Delaware County Board of DD on January 11, 2019. DODD proposed vocational habilitation compliance was discussed with the implementation date of August 2019. Direct support professional minimum pay will be proposed for biennium budget. OPERS bill was signed by Governor on 12-21-2018 and will go into effect March 2019 so all county board classroom aides will receive a full year credit for retirement.

Mr. Campbell went over the 2018 Annual Action Plan Outcome Summary.

Business Manager Ray Heaston reported Carroll Hills School parking lot pavement scheduled for this year is placed on hold due to tying into the sewer line. ResCare Ohio will give their residents the option to choose a private provider of day services. He estimates the Board contract with ResCare will be reduced from 8 to 5 individuals attending Board services. The Board contracted with Eagle Consulting to address HIPAA compliance. In order for the Board to become more HIPAA compliant encrypted email was purchased called Zix Corp.

In other business, the Board:

- Approved payment of \$1,141.82 for November bills in the Hot Lunch account;
- approved payment of \$69,150.03 for November bills in the General Funds account;
- approved payment of \$25,767.25 for November bills in the Residential Services account;
- approved payment of \$127.57 for November bills in the DD School Levy account;
