At the regular June meeting of the Carroll County Board of Developmental Disabilities held June 30, 2016 the Board heard from Superintendent Matt Campbell attended the Superintendent Executive Committee meeting on June 10, 2016 held at Franklin County Board of DD. Topics of interest included STABLE accounts, HCBS Waiver redesign for adult day and employment services, overtime payments to independent providers, and Mid Biennium Review update.

Mr. Campbell attended the Ohio Association of County Boards 2016 Spring Conference held on May 12 and 13 at the Columbus Hilton Easton. Sessions included DODD and Medicaid updates, increasing provider capacity, best practices in SSA transition coordination, transforming to a community based service model, and remote monitoring and technology.

Mr. Campbell reported turning in the 6 month benchmark report to Ohio Department of Developmental Disabilities. The benchmark report is a new requirement by Ohio Department of Developmental Disabilities to track the progress of the Board meeting the Centers for Medicare and Medicaid Services 2014 rule on Home and Community Based Services. The Board continues the separation of Service and Support Administration (SSA) function from workshop duties. The Board continues to provide transportation to 2 individuals receiving Medicaid Waiver dollars as a provider of last resort. SSA staff are approaching providers for transportation. The Board has reduced census at Carroll Hills Industries from 37 to 35 individuals receiving Medicaid Waiver dollars. The Board also purchased ImagiNetwork provider recruitment services from Mid-East Ohio Regional Council.

In other business, the Board:

- approved payment of \$1,878.95 for April bills in the Hot Lunch account;
- approved payment of \$325,659.12 for April bills in the General Funds account;
- approved payment of \$38,723.34 for April bills in the Residential Services account;
- approved payment of \$71,250 for April bills in the Clean Diesel Funding Assist Program account;
- approved payment of \$416.75 for May bills in the Hot Lunch account;
- approved payment of \$84,198.10 for May bills in the General Funds account;
- approved payment of \$3,392.28 for May bills in the Residential Services account;
- approved payment of \$5,423.64 for May bills in the DD School Levy account;
- approved the Program Division Reports;

- approved fiscal year 17 \$11,427.50 matching funds to continue Strong Families and Safe Communities grant in collaboration with ADAMHS Board of Tuscarawas and Carroll Counties and Tuscarawas County Board of DD;
- approved new 2016 salary ranges;
- approved purchase of business, investigative, and quality products from Mid-East Ohio Regional Council for approximately \$76,000 per calendar year 2017 and 2018;
- approved 3 new applications and 14 renewals for Family Selected Services;
- entered into executive session at 5:40 pm to consider matter required to be kept confidential by federal law or regulations or state statutes. Executive session ended at 5:56 pm.
