At the regular June meeting of the Carroll County Board of Developmental Disabilities held June 22, 2017 Mr. Campbell signed the early intervention service coordination subgrant agreement between Carroll County Board of Developmental Disabilities and Stark County Educational Service Center as Administrative Agent for Stark County Family Council Board of Trustees. Carroll County is due to receive \$41,381 from the Ohio Department of Developmental Disabilities for service coordination. Stark Educational Service Center will apply for the grant, act as the fiscal administrator, and provide supervision to the Board hired service coordinator for a cost of \$12,566. The rest of the grant funds \$28,815 will pay for the salary and benefits of the Board employed service coordinator.

Mr. Campbell reported July 10<sup>th</sup> is the date to move Carroll Hills Industries (CHI) to 1182 Roswell Road and the rest of county board staff and individuals without Medicaid Waiver funding to Board owned 540 High Street NW. All 3 lots that were donated by Carroll Hills Industries are now Board property. The garage was removed from the new lot at the rear of 540 High Street NW and an estimate was accepted to remove a large tree and trim the existing trees. Plans are for the lot to be leveled and a fence added so the area may be used for leisure.

The Board is in need of a new Board member. Becky Arbogast stepped down as a Board member and the Board thanks her for her service. If someone is interested please call the Administration office at 330-627-6555 to complete an application.
