At the regular March meeting of the Carroll County Board of Developmental Disabilities held March 23, 2017 the Board heard that Superintendent Mr. Campbell attended the Ohio Superintendents of County Boards of DD 2017 Winter Conference on March 9, 2017 at Nationwide Hotel and Conference Center. The Keynote speaker was Jonathan Martinis presenting on supported decision making: protecting rights, ensuring choices for people with developmental disabilities. Other topics covered were alternative ways to spend the day for adult day services and financial planning for current issues facing Boards.

Mr. Campbell attended the Ohio Superintendents of County Boards of DD Superintendent Executive Committee meeting held on March 10, 2017 at Delaware County Board of DD. The Ohio Department of Developmental Disabilities Deputy Director for Policy and Strategic Direction Teresa Kobelt discussed updates on Early Intervention. Ohio Association of County Boards Executive Director Bridget Gargan provided updates on independent provider overtime rule and state budget issues.

Ray Heaston, Business Manager reported contacting Kathy Stoneman to complete title search and property transfer for 3 lots Carroll Hills Industries is donating to Carroll County Board of Developmental Disabilities. Renovation of 1182 Roswell Road has started. 540 North High Street front office renovation will begin April 27, 2017. The goal is for Carroll Hills Industries staff and individuals receiving Medicaid Waiver funding to move to 1182 Roswell Road and all board staff move to 540 North High Street on July 1, 2017.

In other business, the Board:

- approved payment of \$468.87 for February bills in the Hot Lunch account;
- approved payment of \$51,966.41 for February bills in the General Funds account;
- approved payment of \$4,138 for February bills in the Residential Services account;
- approved the \$27,829.25 quote from Gotch & Company Inc. for landscaping at Carroll Hills School. The building has dirt mounded up to the walls with bushes planted that are dying off. The quote is to remove the mounds and bushes and replace with non-weathered Versa-lok retaining walls.
- Approved 1 new application for Family Selected Services and 2 employee secondary employment notices.
