At the regular March meeting held on March 29, 2018 Mr. Campbell attend the Superintendent Executive Committee meeting on March 9, 2018 at Delaware County Board of DD. Topics of interest included financial forecasting, state funded Developmental Center criteria, parents upset over the new required Electronic Visit Verification (EVV) system, and the Fix the List campaign. EVV is required for all waiver-funded personal care services by 1/1/19 and for all home health services by 1/1/23. Families are mailed a device that they are required to ensure remains charged and direct care staff will log in whenever at the home to provide services. This allows verification of what service provided, when, where, for how long, and is verified by the family signing off on the service. Superintendent Matt Campbell mailed information to everyone on the current waiting list about Fix the List details which explain the change in waiting list rule. Waiting list rules will change July 1, 2018. Everyone on the current list will need assessed for immediate or current needs. You will only be on the Waiver waiting list if you are assessed to live in Carroll County and are in current need of Waiver funding for services. If it is an emergency or immediate need the Board must address the issue now. If you have any questions please call Superintendent Campbell.

Mr. Campbell investigated several options to increase security at Carroll Hills School and Carroll County Board of DD. Clear book bags have been purchased and will be distributed after spring break. Metal detector and armed resource officer estimates were acquired. Mr. Campbell used the Superintendent list serve to survey county board schools on security measures. Principal Ryan Buck sent a survey to Carroll Hills School parents on proposed increased security measures. Mr. Campbell recommended hiring a School Resource Officer and purchasing a hand held metal detector. Security cameras have been increased to 16 at the Board offices and are in the process to expand to 16 at Carroll Hills School and will cover the playground. It was recommended by Commissioner Robert Wirkner to change the current key lock system at both buildings to a key fob system at each main entrance for extra security.

In other business, the Board:

- Approved payment of \$891.18 for February bills in the Hot Lunch account;
- approved payment of \$67,757.39 for February bills in the General Funds account;
- approved payment of \$11,413.24 for February bills in the Residential Services account;
- approved payment of \$849.90 for February bills in the DD School Levy account;

- approved the 2018 – 2019 Carroll Hills Program Calendar;
- approved the program division/committee reports;
