At the regular May meeting held on May 24, 2018 Mr. Campbell attend the Ohio Association of County Boards 2018 Spring Conference held at Hilton Easton on May 10 and 11. Behavioral Scientist James Kane delivered the keynote speech on “The Loyalty Switch”. Topics of interest included Provider Guide Plus a 5 star rating system for all agency providers, crisis communication best practices, levy language changes, and building capacity for youth with intense needs.

Mr. Campbell proposed revising the Family Selected Services procedure. The Family Selected Services (FSS) program assists a family who keeps at home a family member with a developmental disability. It also assists the individual to maximize self-sufficiency and prevent inappropriate institutionalization. The Board agreed with Mr. Campbell revision to the Family Selected Services procedure. FSS allocation will be increased from \$700 to \$1,000 per year starting July 1, 2018. A family will now have access to the entire \$1,000 regardless of when the Ethics Committee approves the application.

Tuscarawas and Carroll County Boards of Developmental Disabilities and Family and Children First Councils are excited to announce new collaborative efforts to strengthen and build services for youth with both developmental disabilities and intensive behavioral needs and their families. Throughout the course of this next year the agencies will be offering several free trainings. The first will be on June 5, 2018 from 8 am to 12 pm at Tuscarawas County Board of Developmental Disabilities.

In other business, the Board:

- Approved payment of \$521.52 for April bills in the Hot Lunch account;
- approved payment of \$102,296.99 for April bills in the General Funds account;
- approved payment of \$42,914.94 for April bills in the Residential Services account;
- approved payment of \$2,390 for April bills in the DD School Levy account;
- approved the revised Personnel Policies and Procedures Manual;
- approved the membership and purchase of products from Mid-East Ohio Regional Council (MEORC) for 2019-2020 in the amount of approximately \$79,862 due to some products having a per person cost;
- approved the program division/committee reports;
- entered executive session at 6:32 pm to consider the employment and/or dismissal of a public employee. Executive session ended at 6:45 pm.
