At the regular November meeting of the Carroll County Board of Developmental Disabilities held November 15, 2016 the Board heard that Superintendent Mr. Campbell reported on the privatization of Carroll Hills Industries. Phase 1 is close to being completed. Room #2 was moved to room #5 so community employment division can move to room #2 when completed. Staff and individuals have been moved accordingly between the 2 buildings. Once offices are completed at the workshop 3 administrative staff will move there so Carroll Hills Industries can start renovation at 1182 Roswell Road. The Commissioners passed a resolution to transfer 540 North High Street property to the Carroll County Board of DD.

Mr. Campbell asked a Service and Support Administrator (SSA) to attend the last Individual Education Plan (IEP) meetings. SSA Lisa Erwin volunteered to be the student SSA. She will be attending all IEP's for individuals eligible for Board services. This is a new strategy to provide case management services to parents before the age of 18.

The public hearing for the 2017 Annual Action Plan is scheduled for December 5<sup>th</sup> from 2-4 PM at the administration building (1182 Roswell Road NW).

Mr. Campbell and staff met with the Carroll County Health Department on November 1, 2016 to discuss the Board taking over Help Me Grow Early Intervention. The Board would be responsible for central coordination and service coordination. Mr. Campbell will contact the Health Commissioner to discuss further details.

In other business, the Board:

- approved payment of \$1,361.98 for October bills in the Hot Lunch account;
- approved payment of \$116,081.85 for October bills in the General Funds account;
- approved payment of \$20,382.86 for October bills in the Residential Services account;
- approved the 2017 operating budget in the amount of \$4,763,000;
- approved the 2017 resolution to pay the non-federal share of Medicaid expenditures up to the \$215,000;
- approved to pick-up the 5.9% increase in employee share of health insurance premium which is about \$39,000;

The next regularly scheduled meeting is January 26, 2017 at 5:30 P.M. at the Administration Building.
