At the regular October meeting of the Carroll County Board of Developmental Disabilities held October 23rd, the Board heard from Superintendent Matt Campbell that he attended the Ohio Superintendent of County Board of Developmental Disabilities Executive Committee Meeting at Franklin County Board of Developmental Disabilities on October 10, 2014. Topics of interest included Ohio Association of County Boards is drafting position papers on conflict free case management, The Arc of Ohio is holding regional meetings in collaboration with Disability Rights Ohio, Employment First does not mean employment only, there are issues with person centered planning and Commission on Accreditation of Rehabilitation Facilities (CARF), and the Ohio Department of Developmental Disabilities will have a draft transition paper to address the new Centers for Medicare & Medicaid Services rules sometime in November.

Mr. Campbell reported that every year the Ohio Association of County Boards holds a Delegate Assembly in December. This year's resolutions include 2014 -01 to prohibit the use of alcohol and drugs while providing services and 2014-02 to enhance community integration and offer people served by County Boards of DD a greater voice in choosing where to live, work, and spend their time, it is critical for the State of Ohio to fully fund and provide adequate resources to ensure state policy reforms can be achieved.

Mr. Campbell reported House Bill 483 requires county boards to perform due diligence to look at sharing services with another county board when a management position becomes vacant. The Annual Action Plan Public hearing is scheduled for December 8, 2014 from 2:00 to 4:00 pm at Carroll Hills Administration. Surveys are available for public input on Board services related to the 2015 Annual Action Plan on the Board's website CarrollHills.com.

In other business, the Board:

- Approved the Program Division Reports;
- approved payment of \$1,826.94 for September bills in the Hot Lunch account;
- approved payment of \$44,613.18 for September bills in the General Funds account;
- approved payment of \$3,088.30 for September bills in the Residential Services account;

- approved purchase of a new 30 passenger Thomas school bus from Myers Equipment Corporation in the base amount of \$87,238, requesting all options for a total of \$91,763, and receiving \$3,200 for trade in of bus #15 a 1999 International/Thomas;
- approved a 3 year contract with Superior Technology for Information Technology services related to server access, storage, and maintenance at a cost of \$900 per month for the first year and \$1,150 per month for the following years;
- approved 2 new applications for Family Selected Services;
- went into executive session at 6:27 pm to consider employment of a public employee and return to session at 6:38 pm;
