At the regular October meeting held on October 26, 2017 Mr. Campbell attended the Superintendent Executive Committee meeting on October 13 at Delaware County Board of Developmental Disabilities. Michelle Burke from the Ohio Department of Developmental Disabilities gave a presentation on the Data Warehouse. Ohio Association of County Boards Director Bridget Gargan reported working on the 9 month issue for County Board school staff with Public Employee Retirement System and change in Intermediate Care Facility funding. Jye Brechenridge from Ohio Department of Health talked about the progress with central coordination. The waiting list new rule is projected to start April 2018.

Mr. Campbell requested a posting for Director of Education due to Alicia Hall's resignation. The posting ended October 23, 2017 and interviews will occur on Monday October 30th. The Board thanks Alicia Hall for her years of service.

Business Manager Ray Heaston reported the renewal of a contract for one adult to continue attending day services at the Board who resides at Country View Manor. He stated it is time to renew the contract for Information Technology (IT) with Tuscarawas County Board of DD. The total cost for IT services in 2017 was \$21,000. Akron Children's Hospital has purchased therapy department from Mercy Hospital in Canton. Carrollton Mercy Center will continue occupational and physical therapy services but there will be a change in staff.

In other business, the Board:

- Approved payment of \$2,293.33 for September bills in the Hot Lunch account;
- approved payment of \$6,156 for September bills in the DD School Levy account;
- approved payment of \$95,290.25 for September bills in the General Funds account;
- approved payment of \$7,147.76 for September bills in the Residential Services account;
- approved the purchase of a new 2017 Dodge Caravan SE from Furey's Wheel World in the amount of \$24,841;
- approved the resolution to abolishment of seven workshop specialist positions as required to meet Centers for Medicaid and Medicare rules to privatize Carroll Hills Industries on January 1, 2018;
- approved the resolution for an incentive to opt out of Ohio Public Employee Retirement System as a carryover employee starting January 1, 2018 in the amount of \$1,000 for every year of service;
- approved the addendum to the Carroll County Board of Developmental Disabilities contract with Carroll Hills Industries;
