At the regular October meeting held on October 25, 2018 Mr. Campbell reported public hearing for the Strategic Plan was held on October 2, 2018 from 6 to 7 pm at the Board offices. Mr. Campbell received an email from the Ohio Department of Education that Carroll County Board of DD 2018 Special Education Rating is Meets Requirements. The primary basis of this rating is the final special education program data the district submitted through EMIS for the 2016-2017 school year. The Ohio Association of County Boards has a proposed resolution 2018-01 to amend Article VI of the OACB By-Laws by establishing an annual process for determining a county board's three year average of enrollment for the purpose of assessing member dues. Carroll County Board is currently paying \$7,210 and the new rate if approved will be \$9,270. Mr. Campbell received notification that Carroll County Board of DD will be reviewed by The Ohio Department of Developmental Disabilities on January 9 and 10, 2019 for accreditation. Mr. Campbell has approved for the Board to pick up costs of CPR, First Aid, and this year's Board In-Service training for Carroll County providers. He has been approached about also paying for med certification classes. Initial med cert classes are \$100 per person and renewal for med cert 1 is \$25 and for med cert 2 and 3 is \$75 each. Mr. Campbell is also looking at the Board providing on boarding for providers. This is being done in other counties where the Board pays the cost of pre-employment and training.

In other business, the Board:

- Approved payment of \$1,337.82 for September bills in the Hot Lunch account;
- approved payment of \$175,550.83 for September bills in the General Funds account;
- approved payment of \$11,336.14 for September bills in the Residential Services account;
- approved payment of \$11,730 for September bills in the DD School Levy account;
- approved the program division/committee reports;
- approved the Ethics Council recommendations of 2 new and 2 renewal applications for Family Selected Services;
- approved to enter into contract with Eagle Consulting Partners to address HIPAA security in the amount of \$15,900.
- entered executive session at 6:08 pm to consider the dismissal of a public employee or official. Executive session ended at 6:18 pm.
